Public Works Committee: Discussed by Councilman Lowery concerning Garbage Containers for customers. He stated that he would have one here at the next meeting.


Fire Department: There will be a Fire Department Meeting on the 21 of February at 7:00 p.m. at the Fire Department.



Financial Report: It was motion by Councilman Thomas, 2nd by Councilwoman Scott to accept the April Financial Statements. Motion passed.


Old Business: Personnel Policy Meeting, Clean Up and Containers were discussed during the meeting.







Reena Holmes introduced herself and informed the council of her qualifications and that she would like to apply for the vacancy left by her husband, Floyd Holmes.


