

ORDINANCE NO 1998- 5

AN ORDINANCE ADOPTING PRIVILEGE LICENSE FEES
FOR THE CITY LIMITS OF THE CITY OF TURRELL, ARKANSAS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
TURRELL, ARKANSAS AS FOLLOWS:

SECTION 1. Whereas, the Mayor and the City Council of the City of Turrell, Arkansas have been advised by the City Clerk of said City that the privilege license fees previously adopted by the City of Turrell, Arkansas are outdated and outmoded.

SECTION 2. Whereas, the City Council has concluded that the privilege license fee structure for the City of Turrell, Arkansas does, in fact, need to be revised in keeping with current needs and desires to approve and adopt the license fee structure set forth below:

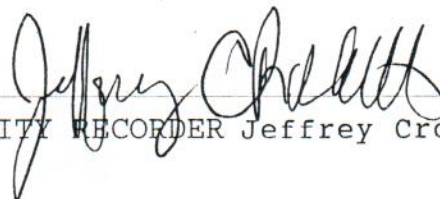
