Minutes of April 4, 2023

Mayor Webster called the meeting to order at 7:06 p.m.

Roll Call: Councilwoman Angela Scott, Councilmen Emanuel Harris, James Lowery, Jeffrey Thomas, City Clerk Dora Jordan, City Attorney Curtis Walker, Recorder Megan Wilhoite, and Mayor Charles Webster.

Absent: Councilmen Cassius Moore and Antonio Greer.

The motion to accept the agenda for April 4, 2023, was made by Councilman Thomas, 2nd by Councilman Lowery. All I's, motion passed.

Reading of Minutes: Minutes of March 7, 2023, were read by Recorder Wilhoite. Motion made by Councilman Lowery to accept the minutes with the necessary corrections was 2nd by Councilman Thomas. All I's, motion passed. Minutes for the Special Called Meeting of March 29, 2023, were read by Recorder Wilhoite. Motion made by Councilman Thomas to accept the minutes was 2nd by Councilman Lowery. All I's, motion passed.

Financial Reports: A motion was made by Councilman Lowery, 2nd by Councilman Thomas, to accept the March 2023 financial statements. All I's, motion passed.

Water and Sewer Projects: A transfer in the amount of \$15,969.69 from the SLFRF to the General Fund: Water and Sewer Department was requested for approval. Councilman Thomas made the motion to accept the transfer, 2nd by Councilwoman Scott. All I's, motion passed.

Committee Reports: Police Department: We are still waiting to receive applications. There will be a new graduating class soon, so we may get a chance to recruit one of the new graduates so that they can gain experience while helping our city.

Community: The community was updated at their most recent meeting of all that has been discussed.

Old Business: Mayor Webster Report

Garbage Truck Update: The application for grant has been submitted, we will be informed of our next steps at a later date.

2023 Calendar Update: Upon receipt of requests, the calendar will be submitted for review and posted for the city.

New Water Tower Bids: The opportunity will be made available at a later date.

New Business: Mayor Webster Report

Ordinance No. 66: PRIVILEGE LICENSES: It was discussed that we educate and enforce the importance of patrons purchasing these privilege licenses to host rummage, or yard, sales within the community. Prices and allotment will be discussed later.

Ordinance No. 85-3: THE OPERATION OF TRUCKS: Many trucks have been noticed traveling through the streets of town. This will need to be enforced due to the trucks altering the roads with wear and tear, making it more difficult to maintain the integrity of the roads. It was discussed that we purchase road signs to be placed in the areas of noticed truck traffic, where they should not be, to make the drivers aware that they are not allowed to travel in the areas. Police and Fire Department will be asked to enforce this ordinance by acknowledging and informing the drivers when they see a truck in a restricted area.

Ordinance No. 1994-3: UNIFORM SYSTEM FOR NUMBERING: It has been noticed that house numberings are not visible from the street. EMS and 911 will be contacted for an updated map of our area with their official house numberings so that it can be enforced that the house numbers must be visible to personnel when EMS or 911 are called.

Fun Part Grant: There is a scheduled workshop with options for dates for personnel who may want information in grants and grant writing.

Adjourn: It was motioned to adjourn the City Council meeting at 8:18p.m. by Councilman Lowery, 2nd by Councilman Harris. All I's, motion passed.
