**Reading of Minutes:** Minutes of April 4, 2023, were read by Recorder Wilhoite. Motion was made by Councilwoman Scott, 2<sup>nd</sup> by Councilman Lowery, to accept the minutes of April 4, 2023. All voted I, motion passed.

**Financial Reports:** A motion was made by Councilman Lowery, 2<sup>nd</sup> by Councilwoman Scott, to accept the March 2023 financial statements and the Expenditure Statement of April. All I's, motion passed.

**Committee Reports:** Community: The community committee meets the last Monday of each month. We need to spread the word to the community of this committee meeting to gain more interest and better attendance in order to assure the community of the goings on.

**Task Force:** Mr. Lowery stated that the homeowner needs to be made aware that they are responsible for having building materials hauled away upon construction, as it is not the city's responsibility to pick up due to the amount of garbage that is already being picked up.

**Fire Department:** ACT 833 application has been filled out and submitted by Chief/Councilman Greer, and now awaits the Mayor's signature upon receipt by e-mail from the Little Rock office. A food giveaway is scheduled for July 7, 2023.

**Beautification:** Councilman Moore spoke with teens from local churches and community members who are in need of service hours to assist in cleaning up during the month of May. It was mentioned that this be made an ongoing availability to assist members of the community who need these service hours and they be counted toward their goals.

**Mental Health Awareness Form:** To make the community aware that May is Mental Health Awareness Month, the council was asked to give Mayor Webster permission to sign the Mental Health Awareness Month Proclamation. In order to apply for the grant, it is required to replace the basketball goals at the city park, upkeep of the park, and the purchase of a new swingset. The cost of these alone will be roughly \$7,000. Upon completion of these, the grant will be applied for.
