AN ORDINANCE ESTABLISHING REVISED RESIDENTIAL AND COMMERCIAL WATER AND SEWER RATES FOR THE CITY OF TURRELL, ARKANSAS 72384

WHEREAS, THE CITY OF TURRELL, ARKANSAS, HAS, BY THE ADOPTION OF VARIOUS ORDINANCES, NAMELY ORDINANCE NO. 2011-2, ORDINANCE NO. 2015-0714 and ORDINANCE 2020-1006 ESTABLISHED WATER AND SEWER RATES FOR SUCH SERVICES FURNISHED BY THE CITY OF TURRELL.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TURRELL, ARKANSAS:
